### **ARTICLE 3: SECURITY**

My Executor(s) and Administrator(s) and any assumed or succeeding Executor(s) and Administrator(s) shall not be required to file or provide any security to the Master of the High Court for the administration of my estate in terms of the Administration of Estates Act (No. 66 of 1965), as amended, or any other law, for the proper performance of their functions.

### ARTICLE 4: DISCHARGE OF DEBTS AND OBLIGATIONS

- 4.1 I hereby direct that the Executor(s) and Administrator(s) of my estate proceed with the distribution of my estate in the following order of priority as commanded by Islamic Law of Succession.
  - (a) Payment of my funeral (burial and shrouding) expenses.
  - (b) Payment of all my debts including expenses of administering my estate.
  - (c) Payment of my religious liabilities and obligations which are set out in Article 4.2.
  - (d) Payment of the *Wasiyya* (Islamic Bequest) which is set out in Article 5. Provided that in the event that the legacy is a pro rata share of the estate then, in such instance, there shall be no order of priority, inter se, between the legatees and my Islamic heirs
  - (e) Distribution of the residue of my Estate to my Islamic heirs in accordance with the Islamic Law of Succession.
- 4.2 My said Executor(s) and Administrator(s) shall endeavour to ascertain what amount, if any, is due by me in respect of my religious liabilities and obligations in accordance with the tenets of Islamic faith as at the date of my death; such as:
  - (a) Unperformed Salaah (Prayers);
  - (b) Unpaid Zakaat (Alms);
  - (c) Unkept Saum (Fast);

- (d) Unaccomplished Haj (Pilgrimage);
- (e) Undischarged *Qurbani* (Animal Sacrifice);
- (f) Sadagatul-Fitr (Charity);
- (g) Sajdah Tilawat (Prostration);
- (h) Outstanding *Kaffarah* (Expiation) for unfulfilled Vows and Oaths.

And accordingly I hereby direct and make Wasiyya (Islamic Bequest) that such amounts shall be paid to such persons or institutions as my Executor(s) and Administrator(s) in their absolute discretion, shall determine to be entitled thereto according to the laws of Islam. The total amount payable under this clause shall not, however, exceed one-third of the net value of my estate after the payment of all my outstanding debts, including funeral (burial and shrouding) expenses. If, however, it does exceed one-third, I request my adult beneficiaries to discharge these outstanding obligations of mine proportionately amongst themselves. However, this request in no way should be construed as binding on the said beneficiaries.

Provided that the Legatee(s) named in this clause is/are not person(s) who qualify as legal heirs according to the Islamic Law of Succession at the time of my death in terms of Article 6 hereof. Provided further that the total value of such legacies does not exceed one-third of the net value of my estate determined as at the date of my death after the discharge of my debts. In the event that the total value of such legacies including my religious obligations in terms of Article 4.2 above, so exceeds one-third of the net value of my estate, the amount thereof will reduce proportionately.

### ARTICLE 6: DISTRIBUTION OF THE RESIDUE OF MY ESTATE

I hereby bequeath the entire net residue of my estate and effects of whatsoever nature or kind wheresoever the same may be situated whether moveable or immoveable, corporeal or incorporeal whether in possession, reversion, remainder or expectancy to my lawful heirs and heiresses to be determined at the time of my death in accordance with and possessions specified by the Islamic Law of Succession.

For the purposes of giving effect to this clause, my Executor(s) shall file with the Master of the High Court a certificate executed by an authorised official of the body selected in 4.2 above.

The said certificate shall set out the full names (if provided) of my lawful heirs and heiresses at the time of my death, and their respective shares in accordance with the rules of the Islamic Law of Succession.

In the event of non-existence of any eligible prescribed Islamic Heirs at the time of my death, the remainder of my estate shall be distributed to an Islamic organisation, namely,

as a contribution for establishing Mosques, Madressas, Islamic Schools or other activities of an Islamic nature.

Should the Organisation named above no longer exist, the Executor(s)/Administrator(s) shall pay the bequest to such other Organisation serving a similar cause. I further direct that the receipt of the duly authorised office bearers of such organisation shall be a good and sufficient discharge to my Executor(s)/Administrator(s).

#### **ARTICLE 7: MINOR BENEFICIARIES**

The share of income or capital which may be payable to minors upon my death in terms of this Will shall not be paid into the Guardians Fund, but shall be held in trust by my Administrator(s) who shall have the right to invest such income or capital in such investments as they may in their sole discretion decide and shall further have the right to apply the whole or portion of the income or capital for the maintenance, education or other benefit of the minor beneficiary, provided that such investment is not in conflict with Islamic Law.

The share of income or capital of such minors shall be paid to such beneficiary upon the latter attaining the age of twenty five (25) provided that my Administrator(s) shall be entitled to pay a portion or the whole of such share to such beneficiary at any time before that, if they are of the opinion that such a minor has attained a degree of mental maturity which would enable such a minor to manage his or her own affairs without any detriment. My Administrator(s) shall keep full and proper accounting records relating to the trust and shall have annual financial statements prepared from the date of my death until the termination of the trust of such beneficiaries.

### **ARTICLE 8: MARRIED BENEFICIARIES**

In the event of any of my heirs under this Will being married In Community of Property, or if their matrimonial regime is subject to the Accrual System in terms of the Matrimonial Property Act of 1984, then I direct that his or her inheritance and income in terms of this Will shall be excluded from the joint estate arising from such Community of Property or from such Accrual System and shall accordingly be the separate, sole and absolute property of such heir who shall have the full power to dispose or deal with such inheritance without the assistance of the other spouse.
