FUND OBJECTIVE

The fund is strictly managed in accordance with Shari'ah (Islamic Law) and therefore does not invest in shares of companies whose core business involves dealing in alcohol, gambling, non-halaal foodstuffs or interest-bearing instruments. The Shari'ah Supervisory Board oversees adherence to the applicable Shari'ah principles. This fund specifically adheres to the standards of the Accounting and Auditing Organisation for Islamic Financial Institutions (AAOIFI) as interpreted by the Shari'ah Supervisory Board.

WHO IS THIS FUND FOR?

This fund is suited to investors with a long-term investment horizon seeking to maximise growth in a Shari'ah compliant fund. They are able to accept the risks associated with equity funds and also the mandate risk of a more limited investment universe.

NON-PERMISSIBLE INCOME

Incidental income deemed to be non-permissible is paid to the charitable trust elected by the Shari'ah Supervisory Board in line with the principles of Shari'ah and the supplemental deed of the fund. Non-permissible income does not form part of the investor's income.

INVESTMENT MANDATE

The fund is a Shari'ah compliant fund which provides investors with cost-effective access to a broad spectrum of local and international listed investments.

REGULATION 28 COMPLIANCE

The fund aims to achieve long-term inflation-beating growth, and therefore may hold a higher allocation to equities than what is allowed in terms of Regulation 28 of the Pension Funds Act. This fund is therefore not Regulation 28 compliant.



The quarter started off with the shock of the Trump administration's "Liberation Day" announcement of tariffs on the trading partners of the US. However, markets were treated to a first-hand experience of Trump's escalate to deescalate negotiation strategy as he eventually postponed most tariffs announced and started negotiations with individual countries.

This resulted in a very strong relief rally in most risk assets over the second quarter of 2025. In US dollar, global equities were up 11.5% (with the US, Emerging Markets, Japan and Europe all around this level). There were differences during the quarter though. The brief rally value strategies had, was unwound – the global value equity index was up 5.8% and the global growth equity index up 17.3% (with the Nasdaq doing slightly better than this). The laggards were China and the UK – both up around 2%.

A significant contributor to all of this was the weak US dollar. The US Dollar Index has had the worst first half of a year since 1973 – down 11%. With all the noise, global bond yields and spreads largely drifted sideways. The Bloomberg Global Aggregate Index delivered 4.5% in US dollar.

With a bit of volatility in between because of Liberation Day, the rand ended the quarter by only 3% stronger against the US dollar. With this backdrop, South African bonds delivered a respectable 5.9% over the quarter versus a 1.9%

return on South African cash (both in rand). In rand, South African equity delivered 9.7% led by the Naspers/Prosus complex and the precious metals miners. South African equities were slightly outdone in the quarter by the return on South African property – up 11% in rand.

Among the asset classes, the underweight in domestic equity contributed to performance, while the overweight in global equity detracted from performance, relative to the benchmark. Focussing in on the domestic equity building block, the overweight positions in industrials and underweight in consumer staples detracted on a sector level. Contrastingly, the fund's overweight to communication services and underweight to health care contributed to performance, relative to the benchmark. On a security level, the fund's underweight positions in Aspen Pharma and overweight in Telkom were the largest contribution to performance, while the underweight to Barloworld and overweight to Afrimat detracted most from performance.

The fund's asset allocation currently comprises 31% in global equity, 67% in local equity, and the balance in cash (non-interest bearing). Due to the constrained local universe, we find a lot more breadth and diversification in our allowable global opportunity set. Therefore, our asset allocation remains overweight global, and underweight local equity, relative to the

benchmark. However, local equities remain the largest absolute allocation, with a natural bias to the materials sector together with small- and mid-caps.

Domestic equity is currently attractive given the current investment climate, and the additional volatility regarding geopolitics and uncertainty on President Trump's tariffs does not help the case for global equities. Within fund's domestic exposure, it is underweight materials and consumer staples, relative to the benchmark, and overweight communication services and consumer discretionary. Furthermore, within the fund's global equity exposure, it remains underweight the US and overweight South Korea. Moreover, the fund is underweight industrials and consumer staples, relative to the benchmark, and overweight the energy and financial sector.

We are seeing a rise in PMI, although still under the recovery levels, and our inhouse Macroeconomic indicators hover within 'Reflation' territory due to the recent PMI print. Therefore, we remain cautious about US growth. We build funds that have positive exposures to quality, value, and growth factors. The fund's dominant style exposure is to quality, which is more defensive and should hold up well in an environment of higher volatility. Buckle up, we have been here before. Investing is a long-term game.
